# DECISION ON THE RESULTS OF THE FIRST STAGE OF THE CALL FOR EXPRESSIONS OF INTEREST TO BECOME ASSOCIATED MEMBER OF THE SHIFT2RAIL JOINT UNDERTAKING

#### THE GOVERNING BOARD OF THE SHIFT2RAIL JOINT UNDERTAKING,

Having regard to Council Regulation (EU) No 642/2014 of 16 June 2014 establishing the Shift2Rail Joint Undertaking, and in particular Articles 4 and 8 of Annex I to this Regulation<sup>1</sup>,

Having regard to Commission Decision N° C(2014) 7084 final of 3 October 2014 on the launch of the call for expressions of interest to become associated member of the Shift2Rail Joint Undertaking (S2R JU),

Whereas:

- (1) In accordance with Article 4 of Annex I of Council Regulation (EU) No 642/2014, the associated members of the S2R JU should be selected through an open, non-discriminatory and competitive call launched by the Commission within three months following the establishment of the S2R JU,
- (2) In accordance with Articles 4 and 8 of Annex I of Council Regulation (EU) No 642/2014, the Governing Board of the S2R JU should organise a transparent evaluation, with a view to assessing, accepting or rejecting the applications for membership on the basis of a detailed list of criteria for selection of the associated members defined in the call document,
- (3) In accordance with Article 4 of Annex I of Council Regulation (EU) No 642/2014, the Commission should take the final decision on the accession of associated members to the S2R JU, taking into account the results of the evaluation by the Governing Board, with a view to ensuring geographical balance, as well as balanced participation of SMEs, of the research community and of actors from the entire rail value chain, including from outside the traditional rail sector,
- (4) The call for expressions of interest to become associated member of the S2R JU was launched on 6 October 2014, as a two-staged process, consisting first of an identification of associated members following an initial evaluation on the basis of the eligibility, exclusion and selection criteria, and second of an evaluation and negotiation of detailed technical proposals,
- (5) A total of 43 applications were received in response to the first stage of the call and an independent evaluation of these applications was organised by the Governing Board.
