

DECISION OF THE GOVERNING BOARD

approving the revised phasing-out plan

N°18/2024

THE GOVERNING BOARD OF THE EUROPE'S RAIL JOINT UNDERTAKING, (hereafter referred as "EU-RAIL")

Having regard to Council Regulation (EU) 2021/2085 of 19 November 2021 establishing the Joint Undertakings under Horizon Europe¹, and in particular Article 17.2 point (a1) and 19(4) point (v),

Having regard to European Parliament and Council Regulation (EU) 2021/695 of 28 April 2021 establishing Horizon Europe – the Framework Programme for Research and Innovation, laying down its rules for participation and dissemination, and repealing Regulations (EU) N° 1290/2013 and (EU) N° 1291/2013², and in particular Article 10(2)(c) and Annex III on the European partnerships,

Having regard to Governing Board Decision N°14/2023³ dated 5 December 2023 approving the phasing-out plan,

Having regard to the consultation for opinion from the EU-Rail States Representatives Group (SRG) dated 9 October 2024 and for advice from the EU-Rail Scientific Steering Group (SSG) dated 26 September 2024, with positive outcome,

Whereas:

- (1) The joint undertakings are set up as Union bodies for a period ending on 31 December 2031 and financed under the EU Multiannual Financial Framework 2021-2027;
- (2) According to Article 10 of the European Parliament and Council Regulation (EU) N° 2021/695, the European partnerships should have a clear life-cycle approach, be limited in time and include conditions for phasing-out the Programme funding;
- (3) According to Article 17(2) point (a1) of the Council Regulation (EU) N° 2021/2085, the EU-Rail Governing Board adopted on 5 December 2023 a plan for the phasing-out of the joint undertaking from Horizon Europe funding upon recommendation of the Executive Director;
- (4) EU-Rail phasing-out plan includes the administrative and operational adaptations needed for a 'winding-up procedure', and the necessary steps, including procedural and process aspects, to complete the phasing-out of the Join Undertaking from Horizon Europe funding.
- (5) In accordance with Governing Board Decision N°14/2023, the other elements of the phasing-out plan related to short and long-terms targets, strategic alignment, and the future financial stability should be further completed during 2024. The revised plan,

after consultation of the relevant advisory bodies, should be submitted to the Governing Board for adoption by the end of 2024.

HAS ADOPTED THIS DECISION:

Article 1

The Governing Board of the Europe's Rail Joint Undertaking hereby approves the revised phasing-out plan enclosed in Annex to this Decision.

Article 2

This Decision shall enter into force on the day following that of its adoption.
