Minutes of the Meeting

1. Introduction

Karel Van Gils welcomed the members to the 9th FRMCS subgroup meeting. He explained that the plenary meeting had been rescheduled due to the first FRMCS Stakeholder Alignment Meeting taking place on Thursday.

Karel also informed the group that the UIC FRMCS Conference would be held in mid-October, during which the initial analysis of the DpG would be presented.

There are no new members present at the plenary.

The agenda was agreed.

2. Minutes of last meeting

The MoM on 20th of May meeting were approved.

With regard to the list of actions:

- **Action 1** is currently in progress (i.e. updating the General Master Plan by incorporating the responses collected through the annual FRMCS deployment questionnaire).
- **Action 2** has been completed, as the face-to-face meeting scheduled for 1st October was confirmed with enough participants.

3. State of play. Presentation for the HL DpG.

Karel Van Gils outlined the proposed agenda for the HL DpG meeting, placing particular emphasis on item 2, which concerns the outcomes of the FRMCS Subgroup. He also noted that the whole package of documents prepared by the subgroup had been distributed alongside the agenda (not to HL DpG).

Results FRMCS deployment survey (questionnaire)

Pascal Désaunay introduced the results of the FRMCS deployment survey (see HL DpG presentation).

There are no remarks from the attendants. Therefore, Karel indicated that the report will be published on the website and used in dissemination activities, e.g., during the FRMCS conference in October and the explanatory webinar. Additionally, Karel informed that the questionnaire would be repeated mid-next year to get more detailed information.

Arild Nybrodahl suggested that it might be useful to have a mechanism to exert pressure for extending the operational life of GSM-R until the FRMCS transition is completed. Wawka explained the limited authority of the European Commission in this matter, as such decisions are subject to contractual agreements with suppliers. It was proposed that this situation be monitored in coordination with UNITEL.

Pascal indicated that a webinar to disseminate the results of the survey is planned for 2 October (note: invitations sent via associations).

State of play (technology, legal & finance, migration scenario's, dashboard)

David Rothbaum, Mario Sela and Pipsa Hallner overviewed the WG1, WG2 and WG3 status and reports respectively (see HL DpG meeting presentation).

Comments and questions on the information shown about the reports were made by the participants and will be included in the presentation. Comments were related to give more detailed clarity on the Working Groups work, internal discussions and intermediate results. Meeting members endorsed progress and initial outcomes (no objections were made).

Draft Advice to ERA regarding the deployment of FRMCS

Pascal Désaunay explained the current status of the draft advice to ERA (see HL DpG meeting presentation). He emphasised this are advice and proposals and not an action plan and referred to ongoing discussions with ERA.

The group consented with the way of thinking and direction of advice for further analyses and development, including discussions with ERA and sector *[Agreement]*

Next steps / Roadmap 2026

Karel Van Gils introduced the next steps and the roadmap of the FRMCS subgroup in 2026 (see HL DpG meeting presentation). This is basis for the work of the diverse Working Groups and should be detailed (action)

Karel Van Gils emphasised that the Plenary supported the working methods of the working groups and would continue to operate in this manner.
