	Time-plan	<b>The duration of the programme is set for 1 January 2023 - 31 December 2030 (8 years). The programme was launched with the launch of the first public call for tenders in research, development, and innovation this year, with support starting in 2024. It is also foreseen to launch public calls for tenders in 2024, 2025 and 2026. Thus, a total of 4 public calls for tenders will be launched, with support starting in 2024, 2025, 2026 and 2027. The expected duration of projects in the programme is 36 months, with a maximum duration of 48 months. The duration of the projects must not exceed the duration of the programme.</b>
	Available budget	<b>The total expenditure of the programme from the state budget amounts to CZK 1 950 million.</b>
	Strategic priorities	<p><b>The programme is aimed at supporting applied research projects whose results have high potential for further application in new approaches, technologies and services leading to enhanced social and economic benefits of transport.
