

DATA PROTECTION NOTICE – Management of EU-RAIL Governance's bodies and meetings PO-6-03

Management of EU-RAIL Governance's bodies and meetings involves processing of personal data, which shall comply with Regulation (EU) N° 2018/1725¹ (the "Regulation").

This data protection notice explains how the Europe's Rail Joint Undertaking (here after referred to as (EU-RAIL) uses any information you give to us, and the way we protect your privacy. Furthermore, it describes the rights you have as a data subject and how you can exercise these rights.

EU-RAIL protects the fundamental rights and freedoms of natural persons and in particular their right to privacy with respect to the processing of personal data.

We provide the following information based on Article 15 of the Regulation.

What is the purpose of the processing?

- Personal data is collected and managed for the purpose of granting access to members of EU-RAIL U bodies listed under Article 91(1) of the Europe's Rail Regulation and visitors to EU-RAIL premises in order to attend either EU-RAIL Governance meetings or meetings with the EU-RAIL Executive Director or EU-RAIL staff.

Which personal data do we process?

Personal data:

- Profession / Organisation
- Personal details (name, surname, contact details, signature)

Why do we process your personal data and under what legal basis?

Personal data:

- Public Interest Article 5 a) of Regulation 2018/1725

How do we protect and safeguard your information?

- Access control and technical measures such as physical locks and/or secure connections and firewalls
- Staff dealing with this processing operation is designated on a need-to-know basis

Who can access to your personal data and to whom is it disclosed?

The following might have access to your personal data:

- EU-RAIL staff (Executive Director; legal and administrative team; Data Protection Officer)
- Individuals/organisations in direct relationship with controller: Chairperson and Vice chairperson of the relevant EU-RAIL body
- Data subject themselves
- The general public: the names of the Members of Governing Board, the Scientific steering group, the States Representatives Group, the System Pillar steering group and the Deployment Group shall be published on the EU-Rail's website. In addition, The CVs and declarations of interest by the Members of the Governing Board shall be available for public scrutiny in the EU-Rail web site (<https://shift2rail.org/about-europes-rail/europes-rail-structure-of-governance/europes-rail-governing-board/>) with due respect to the applicable EU rules on protection of personal data and access to documents. What are your rights and how can you exercise them?

You have the right of access to your personal data and to relevant information concerning how we use it. You have the right to rectify your personal data. Under certain conditions, you have the right to ask that we delete your personal data or restrict its use. You have the right to object to our processing of your personal data, on grounds relating to your particular situation, at any time. In addition, you have the right not to be subject to a decision based solely on automated processing of data, including profiling, if such decision has legal effect on him or her, except for certain situations, such as entering into a contract (as required by articles 14-16 & 24 of EU DPR Regulation).

Information on action taken on the data subject's request to exercise her/his rights shall be provided without undue delay and in any case within one month of receipt of the request. In case of complex or voluminous requests, this period may be extended by another two months, in which case the JU will inform the data subject.

How to withdraw your consent and the consequences of doing this

Data subjects have the right to withdraw their consent at any time by sending a written request to the above-mentioned email address. Please note that withdrawing your consent does not affect the lawfulness of any processing based on your consent before this consent is withdrawn.

Possible restrictions as laid down in Article 25 of the EU DPR Regulation can apply.

How long is the data retained?

- **5 years:** Profession / Organisation; Personal details
