

DECISION OF THE GOVERNING BOARD

Approving the update of the Annex - Flagship Initiatives of the High-Level Paper “A Future Policy-Based Public-Private Partnership for Rail”

N° 8-2026

THE GOVERNING BOARD OF THE EUROPE'S RAIL JOINT UNDERTAKING, (hereafter referred as “EU-RAIL”)

Having regard to the Council Regulation (EU) No 2021/2085 of 19 November 2021 establishing the Joint Undertakings under Horizon Europe and repealing Regulations (EC) No 219/2007, (EU) No 557/2014, (EU) No 558/2014, (EU) No 559/2014, (EU) No 560/2014, (EU) No 561/2014 and (EU) No 642/2014¹, and in particular Article 17(2)(a) and Article 19(4)(u) thereof,

Having regard to the Governing Board Decision n°06/2025 dated 24/06/2025 approving the High-Level Paper “A Future Policy-Based Public-Private Partnership for Rail”².

Having regard to the Governing Board Decision n°10/2025 dated 02/12/2025 approving the Annex to the High-Level Paper “A Future Policy-Based Public-Private Partnership for Rail”³.

Having regard to the Governing Board Decision n°02-2026 dated 09/04/2026 approving the update of Flagship Initiative 4: Innovative EU high-speed rail corridors to the Annex to the High-Level Paper⁴ “A Future Policy-Based Public-Private Partnership for Rail”.

Whereas:

- (1) The EU-Rail Members contributed to improve the content of the High-Level Paper Annex especially the Flagship Initiative 1 "European Simplified and Integrated Railway System", the Flagship Initiative 2 "The Next-Generation Rail Freight Operations with European Digital solutions" and the Flagship Initiative 3 "Resilient and Recoverable Railway System" through dedicated meetings of the Executive Director-System and Innovation Programme Board (ED-SIPB) and of the specific Flagship Initiatives 1, 2 and 3 working groups, including the participation and contribution from the European Union Agency for Railways and EU-RAIL States' Representatives Group Chair.
- (2) The European Rail Research Advisory Council (ERRAC) was consulted and provided comments on the High-level Paper Annex that were considered by the Executive Director-System and Innovation Programme Board (ED-SIPB) and the specific Flagship Initiatives 1, 2 and 3 working groups. A strategic meeting was organised between the

Europe's Rail Executive Director, ERRAC Chair, Vice-Chairs and ERRAC Strategic Programme Group leader to discuss ERRAC's comments and alignment with the ERRAC strategic document "Future Tracks - Vision and Goals for Rail Transport Research & Innovation in a Changing Europe" published in 2025.

- (3) The EU-RAIL Scientific Steering Group and the EU-RAIL States' Representatives Group were informed by the Executive Director on the work for the update of the High-Level Paper Annex at their meetings of 12.05.2026 and 13.05.2026 respectively.
- (4) As stated in recital (3) of Governing Board Decision n°10/2025 the Annex is considered as a "living" document that can be further revised in the future.

HAS ADOPTED THIS DECISION:

Article 1

The update of the Annex - Flagship Initiatives of the High-Level Paper of the "A Future Policy-Based Public-Private Partnership for Rail", set out in the Annex to this Decision, is adopted.

Article 2

Governing Board Decision n°10/2025 dated 02/12/2025 approving the Annex to the High-Level Paper "A Future Policy-Based Public-Private Partnership for Rail" is replaced by this Decision.

Article 3

The Executive Director shall make this decision publicly available on the EU-RAIL's website.

Article 4

This Decision shall enter into force on the day of its adoption.
